CORPORATE SOCIAL RESPONSIBILITY POLICY

- (i) Curative health care, surgery, eye donation camps, skin donation camps, blood donation activities, therapy camps, dental camps, acupressure camps, cataract camps, etc.
- (ii) To participate in building a healthy community through continuing initiatives in several areas of healthcare, with a focus on mother & child care and HIV/AIDS awareness.
- (iii) Literacy / Awareness programs and activities in various social & wellbeing areas.
- (iv) Research activities, economic, industrial, social research, research professorships, research chair, etc.
- (v) Furtherance & promotion of recognized ideologies like the Gandhian and Sarvodaya ideologies, Swami Vivekananda Missions etc.
- (vi) Donations for furtherance of the social work carried out by various NGOs and other entities carrying CSR activities.

(a) CSR Committee:

- (v) The Company may also collaborate with other Companies for undertaking projects or programs in such a manner that the CSR Committees of respective Companies are in a position to report separately on such projects or programs in accordance with the prescribed CSR Rules.
- (vi) The Company may build CSR capacities of its own personnel as well as those of the implementing agencies through institutions with established track records, subject to the prescribed CSR Rules.
